In the event that no Participant in a category is found to be suitable for inclusion by the Jury, such an Award category may be cancelled by the Jury. The Jury may decide to add nominees in the category to maintain the best standards of participation. The decision of the Jury in this regard will be final, binding, non-

contestable and accordingly, the Awards management will not entertain any queries/ claims/ concerns in this regard.

ELIGIBILITY CRITERIA FOR PARTICIPATION IN THE AWARDS

- Participants applying for the AWARDS should either be Indian national or an Indian registered entities or foreign entities with a registered presence in India.
- Only projects/products which are or will be legally available for purchase in India in INR will be eligible for the Awards.
- Projects/Products nominated are eligible if, and only if, the projects were prototyped, designing of the project is completed or if it is offered to buyers between 01/01/17 and 30/06/18.
- The final eligibility of the Participant will be subject to the discretion and approval of the Jury.
- Participation in the awards is subject to the terms and conditions/ rules and regulations laid down herein, as also available on the Website.

TIMELINES AND RECEIPT OF ENTRIES

Efforts will be made to adhere to the defined timelines. However, the defined timelines
are subject to change based on reasons or situations which are not in the reasonable
control of the Awards Management. Awards Management and its sub-contractors shall

not be held accountable/liable for any disruptions / stoppages / interruptions or cancellation of the Awards or its ceremony or any part of its processes on account of situations and incidents beyond its control.

- Last date for receiving completed application forms, along with the supporting documents is June 30, 2018 by 18:00 hrs Indian Standard Time.
- Receipt of application forms after the specified last date of receipt may be permitted only at the discretion of the Awards Management.
- Awards Management will not be responsible for any application forms being deficient or lost due to lack or lapse in any communication on account of internet failure.
- Participation in the Awards in any manner will be construed as a deemed acceptance to the Terms and Conditions stated herein by the Participant.
- Disqualification of entries is at the sole discretion of the Jury which shall be final and binding on the Participants.

CALL FOR ENTRIES & PARTICIPATION

- Participants can apply for the Awards through the submission of the forms attached or as available on the Website.
- A Participant can participate in multiple Award categories or send multiple entries in each Award category, provided that each entry is for a different project. However, if multiple forms are filled for the same project then only the first form will be considered for the evaluation of the Awards.
- Please make sure that the sections of the form are filled up completely.
- Certain sections marked with an (*) are mandatory to be filled.
- The projects submitted for the Awards must have all the mandatory government approvals. The Awards Management is entitled to seek any documentary proof for the information provided in the application form.
- Please make sure that all the supporting documents mentioned in the nomination form, if any, are duly submitted along with the form only, and not separately.
- Nomination forms along with the supporting documents are to be emailed at FDA@businessworld.in
- The Jury has the right to reclassify application forms from one category to another, or drop categories at its sole discretion.

NOMINATION FEE

- Participants can register free of cost for the Awards on the Website.
- For the purpose of nominations, for each category/ entry, the Participant shall be required to pay a non-refundable and non-transferrable fee of Rs. 7,500/- (Rupees Seven Thousand and Five Hundred only) (inclusive of GST).

- Transaction reference number/ Unique Transaction Reference (UTR) number should be clearly and correctly mentioned on all nomination forms failing which the nomination forms may not be considered.
- All nomination forms should clearly mention the GST number failing which the nomination forms may not be considered.
- All the entries submitted before 30 June 2018 will be entitled for an EARLY BIRD DISCOUNT and the nomination fee for each such category/ entry will be Rs. 5,000/-(Rupees Five Thousand only) (inclusive of GST).

COMPLETENESS OF ENTRIES/ DISQUALIFICATION

- Entries will be accepted in English language only.
- Disqualification of the entries is at the sole discretion of the Jury and shall be final and binding on the Participant(s).
- If at any time, during the Awards process or post the Awards, any information provided by any Participant is found to be incorrect in any manner whatsoever, then the Participant will be disqualified from the Awards without any notice.

GENERAL

- The decision with respect to the existence of any category and/ or nomination shall be at the sole discretion of the Jury. In view thereof, no Participant shall raise any claims, demands, costs, damages, judgments, expenses or liability against BW with respect to the same.
- The Participant agrees that he/ she/ it is legally sound, capable and eligible to enter into
 this legally binding agreement and in applying for and, if selected, participating in the
 Awards. The Participant also agrees to the Terms and Conditions laid down by the Awards
 Management.
- If at any time, including after the conclusion of any of the Award ceremonies, any information provided by any of the Participant(s), is found to be incorrect in any manner whatsoever, then the Participant will be liable to be disqualified and / or return the Award and the monetary emoluments provided to the Participant under this Award, if any. Awards Management may also take penal action against such Participant under the relevant provisions of law for providing false information to participate in the Awards.

- Information provided by each Participant is confidential and the same will be used only for the limited purpose for evaluating the Participants entry to these Awards.
- Awards Management or the team appointed by the Awards Management will try to contact the Participant on best efforts basis by any means deemed appropriate.
- In the event if it is not possible to contact any Participant to obtain the information, interview them, etc. such Participant may be disqualified from the Awards without any notice.
- The Participant hereby irrevocably authorizes the Awards Management to use the data and information gathered during and/or after the Awards in respect of the Participant including but not limited to the Participant's logo, information, project details, etc. The Participant agrees that such information or data shall be the property of BW and BW shall be entitled to use the same in its communications including marketing promotions and advertisements along with/without BW's brand.
- Awards Management shall not be liable in any manner for any mishap, accident, injury or damages etc. of any nature whatsoever, caused to the Participant or their attendees during the Awards. Further, Awards Management shall not be liable in any manner for any loss, damage, theft, or any other mishap caused during the Awards to any person including but not limited to the Participant.
- The Participant understands and agrees that merely participating in these Awards does not entitle the Participant to a prize or to any other form of consideration or recognition whatsoever.

The arbitration proceedings shall be conducted by a sole arbitrator appointed by BW. The seat of arbitration shall be at Delhi and the proceedings shall be held in English language only.
